



Eiki International, Inc. Limited Warranty

This warranty is valid only for EIKI brand LCD and DLP™ Projectors purchased in the United States or its Territories from Authorized EIKI Dealers. This warranty applies only to the original purchaser. The original dated bill of sale, sales slip or proof of purchase must be submitted to an Authorized Service Dealer or Authorized Regional Service center at the time warranty service is requested.

Subject to the Obligations above and Exclusions below, Eiki International, Inc (Eiki) warrants this **Projector** against defects in materials and workmanship for a period of three (3) years of ownership or six thousand (6000) hours of use - whichever occurs first. EIKI will repair or replace (at its option) the product and any of its parts which fail to conform to this warranty.

The **Projection Lamp** is warranted to be free from defects in materials, or workmanship for a period of six (6) months ownership or five hundred (500) hours – whichever occurs first.

Only the **Laser Light Engine** in Eiki laser projectors will have a 20,000 hour warranty.

Only the **HLD LED Light Engine** in Eiki HLD LED projectors will have a 25,000 hour warranty.

Only the **Infinity Lamp Projection Lamps** will have a 10,000 hour warranty.

Replacement lamps are warranted to be free from defects in materials, or workmanship for a period of ninety (90) days or five hundred (500) hours – whichever occurs first.

"THE USE OF ANY 3RD PARTY OR AFTERMARKET, NON-EIKI LAMP, SHALL VOID THE WARRANTY OF THE PROJECTOR".

Replacement Parts are warranted to be free from defects in materials, or workmanship for a period of ninety (90) days.

EIKI, through an Authorized Service Dealer or Authorized Regional Service Center, will replace the lamp on a prorated basis. The warranty period commences on the date the product was first purchased from an Authorized Eiki Dealer.

This warranty does not cover (A) the adjustment of customer operated controls as explained in the appropriate model's instruction manual or (B) the repair of any product whose serial number has been altered, defaced or removed.

This warranty shall not apply to cabinet or cosmetic parts, knobs or batteries or reinstallation of the product after repair.

This warranty does not apply to cleaning the product and/or damage to the product due to environmental pollutants such as tobacco smoke, cooking grease or "fog oil".



This warranty does not apply to uncrating, set-up, installation, and removal of the product for repair or reinstallation of the product after repair. Eiki will only pay for return shipping on warranty repairs.

This warranty does not apply to repairs or replacements necessitated by any cause beyond the control of EIKI including, but not limited to, any malfunction, defect or failure caused by or resulting from unauthorized service or parts, improper maintenance, operation contrary to furnished instructions, shipping or transits accidents, modifications or repair by the user, abuse, misuse, neglect, accident, incorrect power line voltage, fire flood or other acts of God, or normal wear and tear.

The foregoing is lieu of all other expressed warranties and Eiki does not assume or authorize any party to assume for it any other obligation or liability.

Eiki disclaims all warranties which may be implied by law (including the warranties of merchantability and fitness), Eiki's liability for any losses or damages resulting from any cause whatsoever, including warrantor's negligence, alleged damage or defective goods, whether such defects are discoverable or latent, shall in no event exceed the purchase price of the equipment.
